I.) Call to Order

IV.) Update on the State of the Arts Initiative

TN Coordinator of Fine Arts, Todd Shipley presented an overview and goal of the initiative. Discussion included music grants and the implementation of these grants. Key Takeaways included equipment, instructional supplies, and student private lessons. Innovative programming was also reviewed. Mr. Shipley also reviewed the vision of the state of the arts including the visual and performing arts instructional resources, grants and targeted supports, arts education data, and the arts professional learning, outreach, and engagement initiatives. V.) ArtsED Tennessee

Stephen

Coleman, Director of Arts Ed TN, discussed the signing and possible revisions to upcoming education bills.

Takeaways included the following:

- Signed by the Governor in May was a series of amendments to TCA 49-6-1019. These amendments, by Sen. Brian Kelsey and Rep. John Ragan, list the concepts now prohibited to be taught in the state's K-12 public schools. This new law was designed to address the course content for history and social studies classes. However, as written this law could impact the content of the state's arts education classes as well. Visual and performing arts educators are encouraged by ArtsEd Tennessee to check with school administration if there is any question that works under study could be construed as in violation of this new law.
- The next session of the General Assembly will consider a bill by Sen. Janice Bowling and Rep. Terri Lynn Weaver addressing the use of supplemental teaching materials in the state's K-12 public schools. In this context supplemental materials are defined as any teaching materials not on the state approved textbook list. The purpose of this bill is to ensure all materials used in class align with the state standards. Any such materials must be approved by the local school board or system administration. Since most of the materials used in music and other arts classes would fall under the category of supplemental, in its current form this bill could require all of these to gain local approval before use in class.
- ArtsEd Tennessee is working through the TDOE to increase enforcement of TCA 49-6-1-25, the statute that requires all K-8 schools to offer music and visual art. Currently 20% of Tennessee's K-8 students do not have access to either music or visual art classes.

Realizing that the most effective arts education advocacy usually occurs at the local level, ArtsEd Tennessee has begun a program to assist individual school systems in the development of local arts advocacy groups. We are seeking names of individuals who feel strongly about the importance of local advocacy and might want to serve as a catalyst in the formation of such a group in their school system.
