- **I.** Call to Order –President Fisher called the meeting to order at 1:05pm Sunday February 19, 2023.

### **III.** Approval of 1.29.2023 Minutes—President Fisher

The motion was made by Ollie Liddell, seconded by Christopher Dye and carried unanimously to approve the minutes of the January 29, 2023 TMEA Virtual Board Meeting Minutes.

## IV. Executive Director Report-TMEA Executive Michael Chester

TMEA Executive Director Michael Chester stated the January financial report is in google drive. TMEA has a current checking account balance of \$53,102.56 and \$32,780.06 in the TMEA savings account. The CMA contribution has been deposited in the bank. Upcoming conference expenses include three additional payments to Conference Direct as well as Gaylord Opryland expenses.

Regional association payments have been paid to TMEA apart from WTSBOA.

Regional lobbyist payments are coming in and additional revenue includes exhibitors and advertising fees. Collegiate refunds are being processed. The full TMEA financial report is in the TMEA Council google drive folder.

## V. Conference Update and Conference Caucus Review

President Fisher updated the board regarding the importance of board member conference registration with early bird rate before March 4. The executive committee will meet Tuesday April 18 and the TMEA board meeting will begin at 10:30am on Wednesday, April 19. President Fisher shared the conference schedule and stated the importance of using WHOVA for conference updates. President Fisher also reported on the dates of the conference caucus meetings as well as the presider schedule. He asked the TMEA board members to make sure all sessions in their respective discipline are covered by presiders.

Presiders are expected to use the Whova app for any updates to the session they have been assigned. Board members are also expected to communicate with President Fisher regarding their attendance at the Wednesday morning board meeting and communicate their specific nights of stay at Opryland Hotel during the conference.

Executive Director Michael Chester stated the executive committee approved the contract with exhibits decorator, Complete Show Services from Las Vegas. The contract is estimated at \$10,000 to \$12,000. Mr. Chester also updated the board on exhibit space contracts and revenue, updates of the conference and all state registration, meal cards, banquet tickets as well as a report on the awards submissions.

Christopher Dye is working with Ms. Crunk to coordinate possibly having the proclamation happen at one of the MIOSM school events. President Fisher asked Ms. Crunk to send him the information so our lobbyist might could help in sending the Proclamation through. Ms. Crunk also reported on several potential MIOSM events TMEA could support in the schools across our state. NAfME will provide graphics and daily posts to use in social platforms. A final meeting is scheduled for February 28 to finalize logistics of getting this information across the state.
